CENTRALLY LOCATED LAW COLLEGE

Rajasthan School of Law for Women is a girls' Law College centrally located at Gandhi Circle, JLN Marg, Jaipur. College is conveniently accessible from all the parts of Jaipur, Rajasthan.

SMART CLASSROOM

HOSTEL

FUNDAMIENTAL DUTIES

Article 51A under Constitution of India

- To value and preserve the rich heritage of the country's composite culture
- To protect and improve the natural environment including forests, lakes, rivers and wildlife and to have compassion for living creatures
- To develop scientific temper, humanism and the spirit of inquiry and reform
- To safeguard public property and to abjure violence
- To strive towards excellence in all spheres of individual and collective activity so that the nation constantly rises to higher levels of endeavour and achievement
- Who is a parent or guardian to provide opportunities for education to his child or, as the case may be, ward between age of six and fourteen years.
