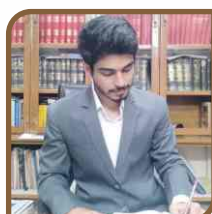

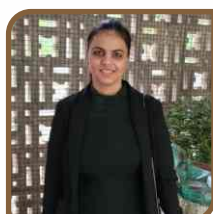

PLAYGROUND

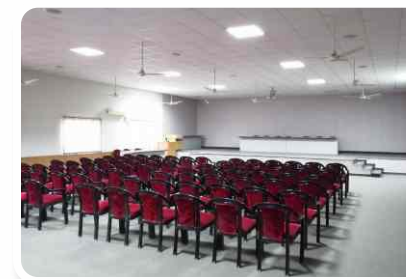
The college has huge playground and adequate arrangement for volleyball, athletics, cricket, hockey, handball and basketball along with guidance of the coach.

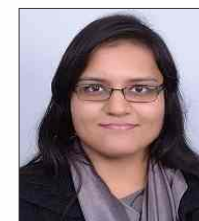

Guest Lectures

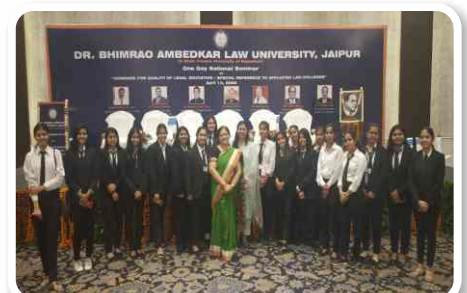


